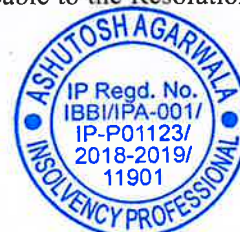

3. The Eligible Prospective Resolution Applicants (PRAs) in the final list are required to submit the Resolution plan on or before 30th May 2024 in prescribed manner as mentioned in Request for Resolution Plan (RFRP).
